Despite all the above the Managing committee in office on 2019 instituted an Inquiry and Disciplinary Committee (IDC) for Mismanagement of the affair of the club and suspended 3 members of the erstwhile committee from 2015. The then President of the Managing Committee Mr. Deshmukh was the President and the Chairperson of the IDC against whom the allegations were made that the Minutes books were incomplete. Ignoring the fact that there were only rough minutes and no fair minutes maintained he continued to be the Judge, Jury and Witness to this unfair practice of suspending the 3 members of the erstwhile Managing Committee. The matter is sub judice and pending in court.
