RULES AND REGULATIONS FOR TEMPORARY MEMBERSHIP

RULES & REGULATION APPLICABLE FOR TEMPORARY MEMBERSHIP AT DADAR CLUB:

1. Rights of Admission reserved with the Club Management. Rights of Admission restricted to the applicant when applying for self. Rights of Admission restricted to minor child when a parent has applied for minor child.
2. Temporary Membership is granted for such period as is specified under the rules of respective department / service. Upon completion of such period, Temporary Membership shall automatically come to an end and shall have to be revalidated by submitting "Application for Revalidation of Temporary Membership" while complying with rules framed thereunder.
3. Entry to Club premises and departments shall be allowed by way of identification through presentation / swiping of membership card only. The Club reserves the right to deny entry to a Temporary Member who is not in possession of membership card at the time of registering entry in to Club. Temporary Member shall be required to carry their membership card at all times while present in Club premises and shall be required to produce it to any employee of the Club / departmental staff as and when demanded for inspection purposes.
4. Temporary Members are required to mark attendance in appropriate registers kept for the purpose.
5. Temporary Member can avail the services of a maximum of 1 (one) department at a time. Temporary Member can avail the services of only that department to which admission is granted.
6. Temporary Member is restricted from accessing other departments, other than the one to which admission is granted, for any reason whatsoever. Temporary Member availing the services of a department, other than the one to which admission is granted, shall tantamount to trespassing and shall lead to immediate expulsion of member.
7. Temporary Member cannot introduce any kind of guest to the Club in any manner whatsoever.
8. Temporary Member is admitted so as to take benefit of a particular department / service of the Club. The Club is not a gathering area for a group of people or friends solicited by a Temporary Member. Hence, Temporary Members are required to enter the Club only for the purpose of utilising the department / availing the services that they have been admitted to.
9. Violation of Club rules / departmental rules / instructions of Club staff / instructions of departmental staff may result in suspension / expulsion of membership by the Managing Committee.
10. No refund / adjustment of fees of any nature whatsoever shall be allowed under any circumstances.
11. A Temporary Member is required to maintain proper discipline and decorum at all times and not cause or be the reason to cause any kind inconvenience to other members of the Club, Management of the Club or service providers of the Club.
12. Gender appropriate attire is compulsory for maintaining decency and modesty inside Club premises. Mobile Phone is to be kept on silent mode inside Club premises. Usage of mobile phone is permitted only on floor lobbies. Photography or Filming inside Club premises is not permitted, unless written approval for the same is taken from the Management of the Club. Parking facility is not available to Temporary Members. Outside eatables, drinks and consumption of tobacco in any form is strictly prohibited inside Club premises. A Temporary Member shall not be allowed to access department / service under the influence of alcohol.
13. All children below the age of 12 (twelve) years shall be required to be accompanied by an adult (Parent or Guardian). Parent or Guardian accompanying such children shall be solely responsible for the safety and security of such children. Any injury occurring inside Club premises must be immediately reported to the Club staff / departmental staff. Dadar Club Management or its employees or its service providers shall not be held responsible in any manner whatsoever for any harm that may occur to a Temporary Member during the course of membership or when such membership is revalidated.
14. Rules & Regulation regarding Temporary Membership are subject to change by the Managing Committee without prior notice. Temporary Members are required to regularly read the notice's put up on the Notice Board of the Club.
15. Coaching / Departmental Service is provided by service providers of repute, appointed by Dadar Club. However, applicants are required to satisfy themselves, by making appropriate enquiries, of the services provided by Coaches / Departmental Service Providers. Dadar Club Management shall not be held responsible and nor shall it entertain any complaints with regards to deficiency of services.
16. Enforcement of rules and regulations are subject to the instructions of Managing Committee / departmental staff of the Club.
17. The rules and regulations stated herewith are for the benefit of Temporary Members in general and are never exhaustive. Departmental rules shall continue to apply in addition to the rules and regulations that are applicable to Temporary Members.
18. In the event of a dispute, the decision of the Managing Committee shall be final and binding.
